The voter-approval rate is the highest tax rate that CITY OF SPRING BRANCH may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that CITY OF SPRING BRANCH is not proposing to increase property taxes for the 2025 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON 09/08/2025 06:30 PM (CT) at FIRE STATION 6, 9850 FM 311, SPRING BRANCH, TX.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, CITY OF SPRING BRANCH is not required to hold an election to seek voter approval of the rate.
